#### From the Vet's Desk

#### **Managing Allergies in Golden Retrievers**

The following is Park 1 of a 2 part article on Managing Allergies in Golden Retriever. Part 2, "Overview of Treatment Options" will be published in the next issue.

It appears that spring has finally sprung in the Seattle area and we are all welcoming the sunshine that seems to have been absent for so long. With the nicer weather, everyone is spending more time outdoors. Unfortunately, the nicer weather also means the start of allergy season for some Goldens and their owners. Allergies can be a year round problem depending on what the individual dog is sensitive to but with all of the world becoming green again, we generally see a significant increase in symptoms associated with Canine Atopy this time of year. Atopy is the medical term for a generalized allergic condition in dogs. Atopy is characterized primarily by itching, foot chewing, excessive licking, inflammation to the eyes, ears and skin. Seasonal allergies can manifest themselves in dogs very similar to what anyone that suffers from "hay fever" is all too familiar with: sneezing, runny nose, and itchy eyes.

Another significant problem associated with allergies in dogs is recurrent ear infections. Often for Goldens, this can be the most difficult aspect of managing dogs with allergies because of their recurrent nature. Often allergic ear problems, or Allergic Otitis is confused with recurring yeast, bacterial or parasitic infections. Owners most commonly complain that they cannot get rid of the "ear mites" that cause the dogs to itch. While there is often an infectious component to the ear problems that we see in dogs, it is important to understand that the primary problem is an inflammatory problem secondary to the allergy, and if we do not focus on controlling the underlying inflammation, we will never control the secondary infection.

To understand how to control allergies, we first have

to understand the underlying problem. There are three main categories of allergies: contact, inhalant and food allergies. Contact allergies are by far the most prevalent allergies that we see. Anything that comes in contact with the skin can potentially cause contact allergies; most commonly this is fleas, dirt, pollens and molds but can include carpet dyes, fabric softeners or detergents and bedding. While there can be a direct correlation between the points of contact and the areas of skin affected (think poison ivy), the contact is often generalized and only the thin sensitive areas of skin become significantly inflamed. The most common areas affected are the skin of the ears, arm pits, abdomen, and groin.

Inhalant allergies will cause sneezing, runny nose and itchy eyes as well as generalized itching to the skin and ears. Pollens, dust and mold are the common causative agents but smoke, perfumes and aerosol sprays can cause irritation as well. Food allergies account for approximately 15% of dogs that have allergic dermatitis. A common misconception is that most of the allergies that we see in dogs are caused by food and while good nutrition is important, most allergic skin conditions in dogs are not directly affected by dietary selection. Unfortunately we cannot control the pollens and environmental contaminants that may cause the contact and inhalant allergies but we can directly control the diet. This is why dietary trials are often attempted to determine a cause and effect relationship.



## **Spotlight On Our Volunteers**

In addition to holding the purse strings for EGRR, Lee Cummings has been fostering homeless Goldens for over 13 years. Lee and her husband, Phil,

live in Renton. They are life-long Cougar fans and met at Washington State University. Lee works full time for the Renton school district having started at the local elementary school many years ago and now has an office at the administration building where she oversees WASL testing for the district. Now down to one Golden, at one point they had 3 of their own Golden Retrievers in addition to 3 children but there was always room in the Cumming's Inn for a foster dog. Their current Golden, Jenny, is getting up in years but still enjoys playing with the young foster dogs.

Lee has experience in many dog-related areas including breeding, showing in conformation and obedience. She has also played an important part in many dog's lives because regardless of the day of the week or the time of the day or the dog, Lee almost always says "sure – we'll take him". Even when her college-aged daughter was recently recovering from knee surgery, Lee was ready to foster again once she knew that Shannon was stable on crutches and would not get knocked over. That is dedication! The Cummings are one of the few foster homes that has a cat – in fact, they have 2 cats – and this provides the opportunity to cat proof the dogs they foster.

Lee is a member of the Renton Disaster Preparedness Team and in her limited free time teaches classes on disaster training. She is also a certified ham radio operator. Thank you Lee for everything you do for the community and for EGRR!



# RESCUE OF THE MONTH SOLO AND TOBY

EGRR experienced another "first" recently when we accepted 2 dogs at opposite ends of the age spectrum. 4 week old Solo is the youngest dog we have taken in and 15 yr old Toby, the oldest. Solo was found along the road in a rural area on the eastside with his sister. The person who took Solo contacted us and the person who took his sister supposedly turned her over to another Rescue group. Solo spent 9 days with the Randalls building up his strength, then he spent over 2 weeks wreaking havoc at the Kieslers. Plans at this point are for him to go to Gloria Miller's house to spend a week with her litter of Golden puppies for some important puppy to puppy socialization. From there, he will go to his forever home.

Toby was rescued from the King County Shelter in Kent where he was turned in by his owner to be euthanized because he was old and not getting along very well. The shelter asked – no, they more like pleaded with us to take him because they just did not feel it was Toby's time to go to the bridge. Toby then spent the next 3 weeks at Karen and Terry Jenkin's home where he romped and played with the five resident Goldens. He was recently moved to Tony and Kathy Bahnick's home where he will spend his remaining days enjoying the good life.

We found it interesting how we could in the span of 1 week deal with 2 dogs at opposite ends of their lives. Solo, who was too young to be weaned when we got him, is just starting out on his journey and Toby, who has seen and done so much we'll never know, is nearing the end of his. Both red dogs with a lot of energy, personality and a need for our services and we are just happy we could be there to help.

#### Board Meeting April 26, 2009 1:30 PM Fairwood Library, Renton

#### **Board Minutes**

- 1. The meeting was called to order at 1:42 PM April 26, 2008.
- 2. Attendance: Nancy Kiesler, Sue Randall, Rich Randall, Lee Cummings, Diane Murphy, Leslea McLean, Jean Whitehead, Roy Talbot, Linda Talbot, Gail Ballenger, and Kim Condrin.
- 3. A motion was made and seconded to approve the Last Meeting Minutes as written. Motion was approved.
- 4. Report of the President Nancy Kiesler
  - a. Volunteer Workload: This year will be a year of growth and sharing the load. Nancy presented a hand out of new volunteers and the current breakdown of responsibility.
  - b. Nancy spoke about the Money market surplus and P&L statement and encouraged members to continue to shop from the links on the website as it generates free revenue and the profits are direct deposited into our account.

#### 5. Committee Reports

- a. Treasure- Lee Cummings presented written income and expense reports for 2008 and 2009 to date, broken down by donations and membership fees.
- b. Fundraising Diane Murphy Presented a committee report. She is concentrating on applying for grants and has narrowed it down to three basic funds that she will be focusing on. Goldstock Fund, Golden Retriever Fund, and Build a Bear Kennel palls grant. Diane would like to be in the loop when we have an intake that's cost would likely qualify as a candidate. Needs an IRS form 990 to complete the grant forms.

Raffle was a disappointment last year so Dianne made patches to sell at the general meeting and other events. Also she revitalized the rescue poster and printed it to be sold.

Diane has scheduled two fundraising events. The first is a one day raffle June 13th. The donated Disney passes are one of the items that is available She will be crating a themed basket around them and is requesting other Disney items to add. EGRR will be hosting the silent action at the breed club Specialty, Sat Sept 5th at Argus Ranch and members will be invited to the BBQ following. Wine tasting has been researched but Diane has not found the perfect venue for this fundraiser yet.

c. Intake- Sue Randall 8 dogs in Rescue She gave a brief run down of the current dogs in foster care. 42 dogs this year to date. Transferred 5 to Purdy for training. 7 dogs currently in foster and

4 of those dogs are over 10 years old.

d. Placement Sue Randall reported that we are doing well with the waiting list at the moment and anticipates the continued growth of our new applicant pool.

- e. Publicity- Kim Condrin reported for the committee. Kim had some flyers printed up for distribution that she offered to the members to distribute and display in prominent locations such at vets offices. They were all dispersed and the group decided we could use some more. Kim will get more printed to hand out to those who did not get them at this meeting and then offer to the general membership for distribution at the next meeting. Kim will also keep track of the flyers and make sure we can thank those that result in business.
- f. Membership -Rich Randall gave a report on membership. A written report was provided. Membership has increased due to added efforts with the intention of supporting our fundraising credentials with regard to qualifying for grants. Secondary benefits also bring in more volunteers to rescue. Also, a considerable amount of additional donations are being sent in on top the membership fee. Rich proposed that we ask foster homes to collect the membership paperwork and fee at the time of adoption. The group decided to include the membership application in the Welcome Letter and then ask the foster homes to follow up on the process and collect the fee for those that choose to join at the time of adoption. Rich will put into a written reason why donation helps rescue to add to the Welcome letter. Leslea and her team will be answering questions about membership along with the initial phone call in order to further these efforts.

#### 6. Old Business

- a. Board Tenure: Nancy discussed accountability for the board which requires a by-law change and that it would be addressed later in the meeting.
- b. Separation from SPDR: Nancy reported and those present confirmed that the transition went very well. No issues associated with the separation from SPDR have been reported. Some EGRR volunteers and or members retained their dual status with both EGRR and SPDR. We are encouraged by the fact that SPDR still refers questions about Golden Retrievers to Pet-finder. EGRR has continue to receive a healthy number of new adoption applications, and our web site gets and average of two hundred hits a week.
- c. Adoption Donation amounts: Nancy Review that we increased to \$250 for dogs under 8 that are not puppies and reported that all the new amounts are on the new applications.

#### Break:

#### 7. New Business

a. By Law changes- Nancy handed out the new By-Laws for approval. Jean made a motion was made to hold the annual meeting each year in the month of May. Seconded and approved moved. Lee made a motion to change the By-laws to change the 3 year term to 5 years terms. Seconded by Jean and approved.

b. Board Elections: Nancy spoke about upcoming annual elections at the general meeting and be contacting current members about their intentions for concerning running for another term.

- c. Frequency of Board meetings: Nancy announced that we need to have additional meeting. It was discussed and decided to hold one after the General meeting in October. Tentatively planned Oct 4th. Location TBD.
- d. General Meeting and Training session: Red Cross will be demonstrating pet first aid. It is Nancy's intent that there will be time for people to socialize and get to know on another. It was discussed by Jean that she would provide additional training on halter options for dogs. Nancy will make copies of the news letter to have on hand as well.
- e. Intakes of dogs with behavior issues: Nancy discussed that we decline any dog with extreme behavioral issues that can be named excessive separation anxiety of aggression. Sue discussed that once we have the dog we have to have deal with the issues and finding the right home for these dogs can be very difficult. Some of these situations can be prevented if we temp test with a dog for dog VS dog issues although the unwanted behavior does not always show during the test and appears later in the foster environment. Jean proposed to hold an annual foster home training seminar to help identify any issues as early as possible to give us the best chance to correct the behavior or at least place them in a home prepared to deal with the issue.
- f. Update on Max: With a heavy heart Jean explained that she has been involved with Max's training and there owners for two years. The family has worked hard with the dog and had formal training with Positive Approach. Unfortunately, EGRR can not place him elsewhere due to the tremendous liability and responsibility that comes with his bite history. The family will not be able to keep him either due. Max will be PTS as he is would legally be labeled a potentially dangerous dog. Nancy will add some info into the foster-home packet to help foster homes look for early signs of aggression or other obsessive behavior.
- g. Tanner: Sue discussed the situation with Tanner and that he is back with Sheila. Sheila needs another temporary foster home while she is traveling. She has been trying to find effective training for his toy obsessive behavior and has sought professional consult. Much discussion was generated about the responsible options we had in finding the right owner for Tanner such as Pet-finder or network with another rescue group. The bottom line after a thoughtful and thorough conversation is that Tanner is a liability and it is recommending that he be PTS.

#### 8. For the Good of the Order

Roy asked that we put a donor's business card in the news letter as a thank you to their contributions. It was suggested that we create an issue that has a section thank you to all of our sponsors as to not show favoritism to one.

A motion was made and seconded to adjourn the meeting. The motion passed and the meeting was adjourned at 4:26 PM.

#### **Board Minutes**

- 1. The meeting was called to order at 2:10 PM May 17, 2009.
- 2. Attendance was recorded and is attached to the Board minutes.

  President Nancy Kiesler welcomed all the members and facilitated introductions. Nancy proudly noted that this is EGRR's first General Board meeting as an independent 501c3 charity.
- 3. The minutes were read by Leslea Mclean. A motion was made and seconded to approve the last Meeting Minutes as written. The motion was approved.
- 4. Report of the President-Nancy Kiesler
  - A. Nancy reviewed the notable accomplishments in 2008. Foremost is the smooth separation from SPDR. Further noted were the increased hits on the web site, (getting close to 300 a day) and the inaugural issue of the newsletter The Golden Nugget. Nancy also invited the volunteers to become guest writers in future publications. Additionally reported was a significant increase in membership and in the volunteer base.
  - B. Goals for 2009-20010-
- Continue to expand the volunteers and distribute the load to avoid burn out. Find ways to move volunteers up the ladder and increase training to provide overlap and support.
  - -Increase the number of foster homes
  - -Expand the web page. New co-web page manager
  - -New program. Sr's for Seniors. Nancy is still Ironing out the details. Basically the program would waive the adoption fee for senior dogs to senior adopters. This will be featured and supported on the web-page.
  - -More training. Reave suggested web-cam training so we are hoping to put something together that allows training at home on their computer.
  - -Maintain financial stability.
  - C. Nancy offered an answer to a previous election officers question: What do the board members do and how much time is expected to fulfill a position on the board. The time involved varies from 10 to 20 hours a week but this year Nancy will also be expecting board members to have an additional volunteer job or responsibility in the rescue process.

Nancy then introduced the foster dogs in attendance

- -Star: Nancy spoke about his progress and his new surgery. He is a happy boy.
- -Toby: 15 year old overweight male that owners wanted to euthanize. The shelter called us to take him. He is a great dog with kids and other dogs. Loves to play.

#### 5. Treasurer's report– Lee Cummings

Financial Review –Lee was present at the meeting and provided an oral review to those present as well as a written report which is attached to the Board Minutes. Reminded shoppers to shop thru IGive as it raises money for rescue at 2 cents a hit.

#### 6. Committee Reports

- A. Intake- Desiree was not present so Nancy reported on the dogs coming into rescue.
- B. Placement- Sue was not in attendance so Leslea talked about the importance of getting to know the dogs and advantage of support and input from the foster homes.

Additionally we will be holding another fundraiser Sept 5th during the Specialty at Agrus Ranch. They have graciously invited EGRR to the BBQ and allow us to hold a silent auction with donated artwork and other wonderful items.

- D. Membership- Rich Randall was not in attendance but Nancy reported on membership. A written report was provided.
- E. Volunteer- Sachi our volunteer coordinator reported that things are moving along but she is still missing a few volunteers updated paperwork and invited those that know who they are to turn in their paperwork.
- F. Web Page- Brad reported that our EGRR site gets almost 300 hits a week. The more hits we get the more we move up in the priority.
